SYNOPSIS:

On November 13, 2009 at approximately 1653 hours, I was dispatched to the listed address, in reference to trespassing. I was advised by dispatch that one of the trespassers was sitting on the patio area antagonizing customers. Upon the conclusion of my investigation, Mr. Blomquist was arrested for trespassing and disorderly conduct and transported to the Pima County Adult Detention Center were he was booked in on the charges.

NARRATIVE:

On November 13, 2009 at approximately 1709 hours, I arrived at the location and met with the reporting person, Erv Schultz, who stated that Mr. Blomquist had arrived at the location, sat down at a table on the patio area and requested a beer. Mr. Schultz stated that he refused to serve Mr. Blomquist and that he had advised Mr. Blomquist that he was not welcome to patronize the restaurant and that he was trespassed from the location numerous times in the past. Mr. Schultz stated that Mr. Blomquist refused to leave and stayed at the table. I asked Mr. Schultz if any of the customers were willing to be a victim and he stated "no, they are here for a wedding". Mr. Schultz stated that Mr. Blomquist was trying to make a "in your face" statement that he could go and sit wherever he pleased.

I contacted Sgt. Brunenkant #161, advised him of the situation and he advised me to arrest Mr. Blomquist for trespassing and disorderly conduct.

I approached Mr. Blomquist, who was still sitting in one of the restaurant's chairs at a table located on the patio, and advised him that he was being placed under arrest for trespassing and disorderly conduct. I double lock handcuffed Mr. Blomquist ensuring proper tightness, escorted him to my patrol vehicle and had him enter the back of my patrol vehicle. Once inside the back of my patrol vehicle, Mr. Blomquist asked if I had discretion on handcuffing him and I informed him that I did not and that anyone under arrest was handcuffed. Mr. Blomquist requested that I loosen the left handcuff due to it being "too tight" and I did.

Mr. Blomquist stated that he was within his rights to be where he was and I informed him that he was utilizing the property of the restaurant and that he was advised that he was not welcome there. Mr. Blomquist stated that "they put the chair in the easement, so I can use it".

Mrs. Cummings and Mrs. Chamberlin were also at the location with signs but confined themselves to the parking lot area.

While transporting Mr. Blomquist to the Pima County Adult Detention Center, Mr. Blomquist stated that he had arrived at the restaurant early, so that he was there prior to the customers so that they would not know he was part of the protesters.

CONCLUSION:

Mr. Blomquist was transported and booked into the Pima County Adult Detention Center at approximately 1827 hours under ARS 13-2904 Disorderly Conduct and ARS 13-1503 Criminal Trespass under booking number 091113132.
