**NARRATIVE**

The complainant works as a loss prevention officer for Dillard's department store. He observed Vazquez on video surveillance as she walked to the clothing rack. She removed the sweater she was wearing and then took the listed jacket from the rack where it was displayed for sale. She tried on the jacket and looked in the mirror to see if she liked it. A short while later she positioned herself between two racks and concealed her jacket in the sweater she had taken off. She purchased some shoes and other items, but left the store without paying for the jacket which was still concealed in her sweater. She was detained by security and 911 was called. I was dispatched in response.

Swineheart showed me the video and gave me a copy of the recording which was placed into evidence. He also told me that he went through the items in her possession locating a pair of earrings not purchased at the store.

I spoke to Vazquez after Miranda ("Yes, Yes".) I told her I had watched the video and described what was seen. She acknowledged that what I had seen was accurate. I asked if her intentions were to still the items (both the jacket and the earrings) and she responded, "not at first, but I did and I have no excuses for it." She acknowledged she had a credit card in her possession she could have used to purchase the items, but did not.

Vazquez was cited and released for shoplifting. She has been trespassed from Dillard's as well as the Tucson and Park Place malls. She acknowledged she is aware this includes professionally and as a customer.

Mrs. Vazquez was compliant and uninjured at the time of her release. She was allowed to leave with the items she had purchased.

Photographs were taken both of the recovered items and Vazquez.
